Part D. Terms and Conditions of Enrollment.

1. **Class size.** All group courses with 6 lessons a week: maximum 10, minimum 3 students. If there is only one or two students in the class, the number of lessons is reduced to 12 lessons for every 4-week session and you will receive private (semi-private) classes at a discounted rate. Private/semi-private classes may be taken one time a week for 4 weeks (3 lessons a day), or two times a week for 2 weeks (3 lessons a day). 1 lesson = 45 minutes
2. **Cancellation before the beginning of the classes.** You must inform the office in writing. Any refunds will be made within 30 days of cancellation notification. If the course is cancelled more than 30 days, we will make a full refund less non-refundable application fee and placement test fee. If the course is cancelled 30 days but more than 14 days before the course begins, the cancellation fee is charged in the amount of \$100.00. If the course is cancelled 14 days or less before the course begins, the cancellation fee is charged in the amount of \$200.00.
3. **Cancellation after the course has started.** In no case money will be refunded once the course has started. No refund can be given for partial attendance or the discontinuance or interruption of a course.
4. **Holidays.** Should a national holiday fall on a class day, group class hours cannot be recovered, nor are they refundable. Private classes, however, will be rescheduled. It is the student's responsibility to find out when the school will be closed for national holidays. There are no classes if the Building is closed due Hurricane Warning.
